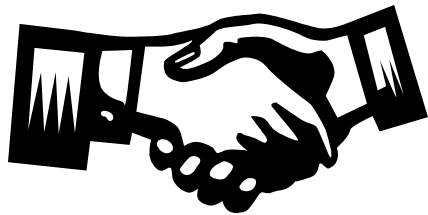


## What is an EDC?
